

# NEBRASKA SYNOD, ELCA LOOKING AHEAD TO 2022 JANUARY 2, 2022

Another year passes and a new one begins, and we face the transition with hope but a little bit of trepidation. A year ago, we were confident that 2021 would have to be better than 2020, only to find that our confidence was misplaced. We face 2022 a little more cautious with our optimism than we have been in other years. COVID has taught us to assume nothing and to be ready for anything.

As troubling (and exhausting) as this has been, it's also taught us some things. We have learned to be flexible, to change quickly, to experiment, to try new things and to be patient. These are all helpful traits to take us into a 2022 that's tinged with trepidation yet filled with hope.

As a church, we in the Nebraska Synod have much to be thankful for in the year past, and much to look forward to with hope in the year ahead.

Increased vaccinations and precautions mean congregations are beginning to see a return to pre-pandemic levels of attendance and participation (though it's highly unlikely we'll ever see a full return to those numbers). Vaccinations and precautions also mean it's possible for synod staff to be traveling to congregations to lead worship, share resources and help people develop into disciples (just contact the synod office to invite one of them to your congregation).

The Vitality Initiative for Congregations continues to engage congregations in cohort learning about who they are and who God has gifted them to be in their communities. The current cohort will complete its first year later in 2022 and continue into 2023, sharing what they learn along the way.

Leadership efforts like the offerings of Emmaus Lifelong Learning have multiplied greatly for 2022, and promise learning opportunities for all levels of engagement and education. For leaders, *How Then Will I Lead?* continues to be offered as an experience to deepen and broaden self-awareness and leadership skills.

We'll be gathering for the 2022 Synod Assembly, in person for the first time since 2019. At that assembly, we'll be selecting the next bishop to partner with us in leading the Nebraska Synod. The election process begins February 5 with cluster gatherings around the state. More information is on its way to your congregation. Please hold this process in your prayers daily.

We will also celebrate with the whole ELCA the National Youth Gathering that will be held in the Twin Cities in July, and prepare for the Churchwide Assembly in Columbus, Ohio in August. Both events are energetic expressions of what it means to be church together, and serve as reminders that we are part of a church that is not only national but global, having an impact on lives and communities all over the world.

Without a crystal ball, it's impossible to know all that 2022 will hold, but we may in both faith and confidence head into this new year with hope for the mission and ministries we share, knowing the Spirit will continue to strengthen us and inspire our imagination for whatever 2022 might bring.

#### PASTORAL REPORTS

# TRANSITION SENIOR PASTOR PASTOR STEPHEN GRIFFITH

It is a pleasure to serve as your Transition Senior Pastor as you work through the process of calling a new pastor. These next months will be busy. I expect they will also be very rewarding.

This time of transition is a journey. It will probably seem at times like we're not moving very quickly, not accomplishing a lot. At other times we will feel like we can hardly keep up with everything that's happening all at once. It is normal in a time such as this that many of us will be anxious. Fear, uncertainty, and doubt are common during the transition process. I will strive to speak words of encouragement and hope so we can stay focused on the calling before us.

Some aspects of the work require rigorous confidentiality on the part of the Call Committee and the Council. We will work hard to keep the congregation informed about the process and the Call Committee's progress, but there will be times when people ask for information that we cannot divulge. We will probably experience some surprises together, and I can almost guarantee we will make unexpected discoveries together. Along the way, I'll try to keep reminding us that we're not alone in this process, for God is walking this way with us, leading us, and sustaining us.

As I begin this work among you, I have very few specific things to report. I have begun learning your names and am getting acquainted with the staff and leadership of the congregation. Pastor Duminy and Pastor Hall are very patiently trying to help me understand the complex structure of the Kountze Memorial organization. We are reviewing staff relationships to boards and committees, and have begun planning for Lent, Holy Week, and Easter.

The Council has begun the work of drafting the congregation's Ministry Site Profile. The Call Committee has been installed and have participated in a training session led by Synod staff.

The COVID Task Force met in early January and recommended that we continue to require the use of face masks at all activities in the building. They will continue to meet often and are monitoring the situation closely.

May God give us grace to bear one another up, wisdom to perceive where God is leading us, strength to follow the path, and the hope and peace that comes through trusting in Christ's constant love.

# Associate Pastor Pastor Shari Duminy

As I sit down to write this annual report and reflect on my first year of ministry with the saints/sinners of Kountze Memorial, a song keeps playing in my mind. This is a song that was introduced to me my senior year of college. In January, my final semester at South Dakota State University, I interviewed for the program director of a church camp just 70 miles away. I had worked at this camp the previous summer. I got the job and spent my weekends from February to May getting ready for the summer youth camp while hosting weekend retreats.

At a gathering with the Minnesota Outdoor Ministry Staff that spring in Green Lake, MN this song was shared with me for the first time. The Church Song, was written and sung by musician Jay Beech in 1988 to be used at camps the next summer. It was a reminder that the church is indeed the people, on the move with God's great love to share in the world in word and deed.

The chorus has these words: We are the Church, the body of our Lord; We are all God's children, we have been restored. I give thanks to a God who claims us and leads us forth in life through grace, abundance, and forgiveness. As God's gathered people, in this place, we have much for which to give thanks and praise in spite of the continued pandemic and a change in leadership this year. We are so grateful for the ministry and work of the following that came to an end this year: Pastor Olaf Roynesdal, Pastor Inba Inbarasu, Donna Moessner, and Taylor Brown. We ponder also, the new ministry that will begin through Transitional Senior Pastor, Rev. Stephen Griffith.

The first verse proclaims this: The Church is not a building where people go to pray; It's not made out of sticks and stones, it's not made out of clay. We have a beautiful, historic place to gather for worship. We give thanks for the members' care and ability to maintain this structure through the years. We have been reminded again about knowing that sometimes projects last longer than expected. We appreciate your patience and understanding as we hope the Stain Glass Windows are returned to the worship space this coming year. However, prayer and worship of God can happen anywhere. May the Sanctuary we gather in each worship, nurture us to carry worship for God into our daily lives, wherever we find ourselves.

The song goes on: You can go to worship but you cannot go to Church; You can't find a building that's alive no matter how you search. My time spent at the church builds with joy, as the buildings comes alive with all who enter it. Whether for work, worship, meetings, service, or dropping by to say hello, each one brings life to the place. I am grateful to staff, members, and volunteers' time and talents that make a strong witness to the gospel. We uplift the work of Scott Henneman as an outgoing council member and Vice Chair, including his continued leadership with the sale of deFreese Manor.

What helps us in this work is to remember what the next verse of the song talks about: *The Church is not a business, a committee, or a board; It's not a corporation for the business of the Lord.* What I have figured out this past year is that there are many moving pieces here at Kountze. Each one is needed to do God's work together. No one is greater or less. No one is in charge of or over the other. Relationships, open communication, humility, and forgiveness are needed to keep the church body healthy. May we be mindful of this in all of our work, trusting that God will lead and guide us.

Bringing it home, the last verse states: *The Church, it is the people, living out their lives*Called, enlightened, sanctified for the work of Jesus Christ. I am grateful for small gatherings and big events that fill us with all we need to go out and be God's love in the world. I am so thankful to the Worship and Music Committee putting together a wonderful reception that uplifted seven members, who are rostered leaders for their Milestone Ordination Anniversaries this past year. 220 years of service to the larger church was an eventful Sunday of celebrations with Rev. David deFreese preaching. We also had Sunday Morning Breakfast again thanks to the Congregation Activities Committee to celebrate the retirement of Pastor Olaf Roynesdal in November. What joy to share in these times together!

We are the Church, the body of our Lord; We are all God's children, we have been restored. Thanks be to God! Thanks be to you! I appreciate serving with you all at Kountze Memorial. This past year has been a blessing for my life. I am encouraged by all the ways we reach out to our neighbors, and I am especially excited for the beginning work of the Refugee Resettlement Task Force. I know there is more to come and as we continue to worship, grow, and serve. May God continue to lead and guide us into the new year and all the opportunities that lie before us to connect with God's good word and work.

# Associate Pastor for Adult Faith Formation Pastor H. Ashley Hall, Ph.D.

In 2021, we returned to some of our regular activities cautiously and faithfully. I am deeply humbled and honored to serve with such a dedicated team of staff members and volunteers. Thank you for your faithfulness, creativity, and joy during the ongoing pandemic.

Until August (when we returned to offering the 11:00 a.m. Eucharist), Baptisms were held just before or just after the Saturday evening and/or Sunday 9:00 AM Eucharist. After August, we returned to celebrating the Sacrament of Baptism within the normally scheduled liturgies. Likewise, Weddings and Funerals continued with masks and spacing precautions put in place by the COVID Task Force (on which I served with Robert Fonda, Steven Hinrichs, Dan Troxel, Jeff and Robin Perkins, Jim Smejkal, and Pastors Roynesdal and Duminy).

With everyone's faithful dedication to discipleship and cura personalis ("care for the whole person"), were able to resume the following activities and events:

New Member classes and integration, Worship Training, Baptism Seminar and First Communion classes, Good Friday Ecumenical Service, the Inter-Faith Thanksgiving Service, and the combined Thanksgiving Dinner with St. Peter Catholic Parish. In 2022, we hope to add to this list a Lenten Retreat, Altar Guild Retreat, and Lay Eucharistic Minister training.

#### **Adult Forum**

In August, we began offering coffee and cookies between services. I intentionally did not plan too much programing, since reconnecting and socializing were the highest priority. In September, we used the Forum time to honor Donna Moessner (who resigned as Children's Choir director) and welcome new members. In October the congregation put together a wonderful celebration for the clergy (pastors and deacon) commemorating ordination anniversaries (I am very grateful for your expressions of gratitude on the 10th anniversary of my ordination) and to update the congregation on highlights from the Council retreat. In November we announced the formation of a call committee and celebrated Pr. Roynesdal's last Sunday among us as Senior Pastor. In December and into the first few months of 2022, I plan to keep the Forum schedule fairly open and flexible, so as to give ample time for the Council and Call Committee to communicate with the congregation.

#### **Council Retreat**

It was a pleasure to work with a Council committee (Ann Dey, Anne Miller, and Jane Ross) to help plan and organize a retreat for the Council on September 17-18. Our guest facilitator was Prof. Mary Lee Brock (Creighton University).

#### **Healing Gift Free Medical Clinic**

I continue to serve as President of the Clinic Board. The excellent work of the Clinic continues due to our volunteers and our coordinator, Joyce Palmer (see separate report). The Clinic made some revisions to its by-laws in order to better clarify its relationship to the mission of Kountze Memorial Lutheran Church after some questions were posed; these revisions were presented to the congregation at its Annual Meeting (August).

#### Synodical and Church-Wide Service

*Synodical:* I continue to serve Bishop Brian Maas as the Ecumenical Officer of the Nebraska Synod and on the Board of the Synod's educational initiative, Emmaus.

I continue to serve as one of the synod-appointed mentors for Adam Klinker and I served on a Theological Review Panel for the Rev. Ernesto Medina. I was able to participate in an excellent continuing education program throughout the Fall offer by the synod entitled, "How Then Will I Lead."

Churchwide: I continue to serve on the Board of the Lutheran Ecumenical and Interfaith Representatives Network (LEIRN) of the ELCA.

#### **Looking Forward**

In early 2020, I announced to the Council my desire to reduce by half my commitments at Kountze Memorial starting in November of 2021 (the tenth anniversary of my ordination and call). At that time, I proposed a reduction to about 6-8 hours a week (pay commensurate), with general duties for preaching, presiding, and teaching but no other administrative tasks. I met with Pr. Roynesdal and Pr. Duminy about how such duties might be divided across the pastoral and support staff.

However, with the departure of Pr. Roynesdal and the realities of transitional ministry as we await the call of a new senior pastor (this is now my third interim with you all), the Personnel Committee and I have agreed to "pause" this reduction of duties. We will reassess the timing of a reduction of duties sometime after Easter. The reduction should occur no later than January of 2023.

As I stated last year, the initiative for such a change is entirely my own and reflects developments in my primary responsibilities as Associate Professor and Associate Chair of the Theology Department at Creighton University.

Thank you for your vision and dedication, which make my call so spiritually enriching and enjoyable! I am delighted to continue to serve the gospel of Jesus Christ with you all and with my colleagues, Pr. Shari Duminy and Pr. Steven Griffith.

# SEMINARIAN REPORTS ADAM KLINKER

Grace and peace to our siblings in Christ at Kountze!

May blessings be upon the annual meeting and all the many endeavors upon which you, as the Body of Christ are embarking. We wish all the best to Pastor Roynesdal in his retirement and pray for the discernment of the Call Committee in its work. I want to express my gratitude for all that Pastor Roynesdal did in supporting and encouraging me in this journey. He gave me quite a gracious and wondrous commencement into this world and I will be forever grateful. Pastor Hall also continues as my mentor in the candidacy and collaborative learning process. His counsel continues to be of great use and help. And, of course, Pastor Duminy's teaching and mentorship during my clinical pastoral education continues to daily aid me. And having worshiped with you all on January 9, we were blessed to hear Pastor Griffith's proclamation and story and know you are all in very caring and capable hands in this transition time. And here it is: the final semester of my seminary journey at Wartburg Theological Seminary. In November, I was also approved for ordination in Word and Sacrament Ministry in the ELCA—the last step in the candidacy process before ordination. I have had a consultation with Bishop Maas and expect to enter the First Call process soon. In the first week of the new year, I completed the first draft of my senior thesis and by the time you read this, I'll be on my way to my last first week of classes at Wartburg. Where has the time gone?

Our ministry here in year three at Augustana in Genoa continues to be blessed with many faithful disciples. Our education program, shared with the Methodist Church here in Genoa, topped 90 students this fall, and we also started a high school youth group that has attracted 25 young people. We have reached many of the "unchurched" in our community and many of our youngest students have been asking about baptism and the Eucharist, to the extent that we will have a catechumenate program and a mass baptism at our Easter Vigil in April.

JoDee continues her work for Carson Group in Omaha, and William (10), Henry (8), and Mary (5) have enjoyed getting to know life in a small town—making lots of friends and taking part in all kinds of activities.

Being back in Omaha earlier this month and worshiping with so many of our friends at KMLC was a joy. Thank you, as always, for the warm welcome. We thank you for all your continuing prayers for us and know that we pray also for you.

#### **DIRECTOR OF CHRISTIAN EDUCATION**

In light of the pandemic, in person Sunday School was suspended January through August. To provide lessons, Facebook videos were used to provide a weekly curriculum and material to be used at home. Participation was encouraged by having families share their children's work with pictures through social media or email. For Easter, the Christian Education committee delivered activity bags with devotionals, lessons, crafts, and sweet treats for all children aged 2 to 12 that were enrolled in Sunday School.

In 2021, 55 children registered for Sunday School. The Godly Play curriculum continues to be used to teach lessons. This curriculum style is modeled on the Montessori method and is a way for students to engage with their spirituality through wonder and exploration.

The Christian Education Committee hosted God's Work/Our Hands to perform service works within the church. We cleaned the Sunday School toys and helped to remove the dead plants from the garden.

Two social events were held in the fall and winter. There was the family outing to the Bellevue Berry Farm and the Advent Fair.

In December, the elementary students delivered a Christmas program under the direction of Barb Carlsen.

During 2021, the Archives Committee has continued to provide Kountze History Articles for the monthly *Good News* Newsletter. **Thanksgiving Dinner at St Peter Catholic Church – November 25:** This wonderful event means a lot to those less fortunate or whom are missing family during this time of year. Kountze provided and cooked 25 turkeys. Also, a special thanks to all the volunteers who provided pies, delivered turkeys, helped with set-up, clean up, serving, and everything else involved in this great event.

**Looking forward 2022:** We are planning a Neighborhood Gathering June 26 and a picnic September 25 as well as other fun events in the planning stages.

#### **FOOD PANTRY**

2021 Statistics:

Individual Guests 40,109 Households 14,661

The Kountze Food Pantry was open 47 Mondays and 48 Fridays in 2021, for a total of 95 service days. Monday service hours are 10:00 AM - 1:00 PM, with volunteers arriving at 7:00 AM. Friday service hours are 5:00 PM - 7:00 PM, with volunteers arriving at 3:00 PM.

The Pantry saw an increase of 52.6% individuals in 2021 over 2020. This year we began literally counting individuals in each household and discovered the average household consists of 2.73 people. We adjust the amount of product commensurate to the number of people in each household. School aged children, working adults and the disabled need not be present to receive food. In addition, we serve 14 Methodist nursing student families and deliver to refugee families.

The increase in product per person is only possible because of continued pandemic funds being directed to the Food Bank for the Heartland (FBFH) and USDA free, fresh produce boxes. Currently FBFH provides products free of charge, though it is not certain how long this program will continue. We also enjoy donated bread and pastry. In 2021 the Pantry received the following at no cost to the congregation:

FBFH: 204,175 lbs. or 4,344 lbs. each Monday AM USDA: 144,788 lbs. or 3,080 lbs. each Monday AM

Rotella's: 320 lbs. each Monday AM HyVee: 700 lbs. throughout the week

This does not include the generous food and necessary items donated by our congregation and partner congregations, service organizations, and businesses. We have also been the designated recipient of several major food drives. The volunteers continue to receive, move and distribute approximately 10,000 lbs. of food every week.

Methodist Health systems provides monthly clinics for our pantry guests. They regularly administer flu and Covid vaccines, diabetes and A1C testing, colon cancer screenings, body mass index, breast cancer awareness information, and head and neck screenings. They have also provided us with Occupational Therapy and Social Work Services.

We continue an aggressive volunteer grant writing program and have already been blessed in 2022 with awards from several foundations.

#### GLOBAL MISSION

Covid again challenged Christians both here in Omaha and around the world, but we were still able to support our missionaries in the form of prayer, communication, and financial support. Thanks to the generosity of Kountze members, the Global Missions Committee was able to achieve the following projects in 2021:

- 1. Financial support of four missionaries: Rev. Chandran Paul Martin in India, Meghan Brown Saavedra in Mexico, Dr. Stephen & Jodi Swanson in Tanzania, Rev. Rachel Ringlaben in Argentina.
- 2. Prayer support for these missionaries, the American Church in Berlin, the Wittenberg Center, and Dan & Ginny Rath, international translators.
- 3. Continuation of the Alternative Gift program in a "COVID-reduced" form that limited the number of giving options. Just over \$6,100 was raised for our pantry and health clinic and support of an Afghan refugee family in Omaha.

Our overall goal for the coming year is to increase the awareness and participation of the congregation in Kountze's long tradition of being a Worldwide Church.

#### OUTREACH

The Outreach Committee exists to deepen the spiritual life of our members, to invite and welcome guests, visitors, and neighbors with authentic and compassionate hospitality, and to gather us into an enriching faith community, so that our congregation can continue to grow and live as lifelong disciples of Christ.

2021 continued to be a challenging year for Outreach because of the Covid 19 pandemic. The first new member classes held in 18 months happened in September and on October 3rd Kountze welcomed 18 new members into the congregation.

As Outreach Council Liaison I continued to serve as liaison to the Kountze Pantry as well.

#### 2021 Activities

• In September 2021 the committee hosted two classes led by the Rev. Ashley Hall introducing the potential new members to Luther and Lutheranism as well as the history and mission of Kountze. A welcome packet was provided to 18 new members including a ministry handbook, information on our children, youth, and family ministries, as well as stewardship, and a current Good News newsletter. Photographs were taken,

- included in a special insert in the monthly newsletter and added to the church directory. Each new member was assigned to a committee contact who emailed, called or mailed them during the rest of the year.
- World Herald print and online ads for televised and live streamed Lenten and Easter services were placed in March. Since we were open for in person Advent and Christmas services, ads were placed in November & December in the newspaper to publicize this fact to the community. Banners were created and displayed on Farnam and Harney Street lawns to advertise the Pantry.
- In October we cooperated with St. Peter Catholic Church on their winter coat drive. We collected and delivered coats, hats and gloves to that church for their October giveaway where 10,000 winter items were distributed including 3,000 coats.

#### Goals for 2022

- Continue to support new member classes by serving lunches and providing flowers on the day members are welcomed to Kountze. 2022 classes have been scheduled for January and September.
- Increase our participation with St. Peter on their Winter Coat Drive by collecting contributions to purchase new coats, socks, gloves and hats as well as by collecting gently used coats.

#### WORSHIP AND MUSIC

Committee Members: Deb Hinrichs, Senior Pastor, Olaf Roynesdal (until his retirement in November), Director of Music and Fine Arts, Barb Carlsen, Director of Children's' Music, Donna Moessner (until her retirement), Director of Youth Choir, Janet Campbell, and members at large, Jon Natvig, June Anderson, Jeff and Robin Perkins, Dotty Sum, and Pam Johnson. At the time of this report, we want to thank June Anderson for her many years of service representing the choir. Her position will be filled by Bruce Nissen.

The 2021 Worship and Music Committee (the committee), under the leadership of Senior Pastor, Olaf Roynesdal, focused on their goal to provide spiritual and meaningful worship to the congregation and guests of Kountze Memorial Lutheran Church. Primary efforts included the scheduling and planning of weekly worship services.

Each service requires the combined commitment and participation of the Altar Guild, Order of St. John, ushers, greeters, lectors, Eucharistic ministers, bell choir members, children's choir members, and Kountze adult choir members. The committee would like to thank the members of each of these groups for their time and commitment, special gifts, and the contributions they make to the Kountze Memorial worship experience and particularly during this very difficult time of restrictions and limitations.

In addition to the traditional Saturday evening and Sunday morning services, the Committee is tasked with planning and implementing mid-week services during Lent and Advent seasons, Holy Week services, as well as special services for Easter, Reformation, Candlelight Carol Service, Christmas Eve, Christmas Day, and other church holidays. We continue to recognize the need for flexibility as we adjust to changing pandemic numbers and changing

protocols. The staff continued to plan all worship services until June 17 when the committee resumed the planning meetings. The required wearing of masks was suspended during the early summer only to resume in the fall with elevated Covid numbers being tracked. The 11 AM service returned on August 1 and use of the processional resumed on September 12. Advent services, using the Holden Evening Prayer liturgy, focused on the ELCA World Hunger theme "The days are surely coming...." Jeremiah 33:14. The mid-week Eucharist has resumed each Wednesday at 12:15 PM

The choir began singing at both Sunday services on September 12 and has determined that sitting in the front pews on the east side of the sanctuary offers them the best ability to maintain some distance from other singers. The Bell Choir, under the direction of Barb Carlsen, will continue to look for opportunities to perform. The Worship and Music Committee assisted with the planning of Ordination Sunday when past and present clergy and lay ministers were honored for benchmark service anniversaries. A special service to honor Pastor Olaf Roynesdal 's retirement was observed with special music. Due to rising Covid numbers during the fall, the choir did not participate in the joint choir for the annual Interfaith Thanksgiving Service. The Candlelight Carol Service was not held this year due to the continuing pandemic challenges.

Donna Moessner has resigned her position as Director of Children's Music. We thank her for all that she has done to build the children's music program. Barb Carlsen will lead the Children's choir until another director is found.

There is no Youth choir at the present time but Janet Campbell will remain as director should that situation change.

Dotty Sum and Pam Johnson remain as leaders of the Altar Guild and hope to have volunteers again assisting with flowers, candle oil, and paraments. Eucharistic ministers have continued to volunteer to assist with serving communion for all services. The plexiglass barrier is no longer being used but gloves are still worn and individual cups of wine are poured and offered to each person communing.

Reading of the Lessons continues on a volunteer basis. Lectors may use Signup Genius to indicate their availability to read. Even when mask wearing is required, the lector is allowed to remove their face covering while reading the lessons. We continue to read the Psalms responsively.

The OSJ has some challenges with having enough participants to have a Crucifer and two torch bearers at each service. When that is the case, the Eucharistic assistant will act as a torch bearer for the service that is in need.

There has been training for ushers this past year, and lectors and Eucharistic ministers were offered training between worship services on two consecutive Sundays. There is a continued need for more ushers and greeters for each service. Members of OSJ have been trained by Jeff and Robin Perkins as needed.

The Committee continues to endorse the printing of the Liturgy and Lessons in each week's bulletin in order to provide smooth and meaningful worship guidelines for members and guests. We believe this format continues to provide the clearest transition through all of the essential components of worship. Since hymnals have been removed from the pews, the printed bulletin is the only source of worship content available for each service.

The Committee would like to recognize the many and outstanding contributions of Barb Carlsen, Mark Jones, David Gerard, Donna Moessner, Judy Boelts, Anita Morse, and Becky Brusky, for the ongoing talent they share with our church community even though there have been limitations for most of the year. We are especially grateful for the faithful continuous service provided by Mark Jones, Barb Carlsen, and David Gerard during a time of great challenge.

We remain committed to providing a traditional-style worship service. Exploring ways to offer a more extensive and vibrant worship life will continue to be our primary goal as we continue to provide a worship atmosphere at each service that is spiritual, liturgical, and meaningful for all who attend.

#### YOUTH

We started 2021 with a small, but steady group meeting together each week. Time was spent getting to know each other and the new Associate Pastor, who was now in their midst. We began to meet in person again and moved our time to the Youth Room again between services. We made Easter Door Hangers for deFreese Manor

In the Spring, we held some planning meetings about where our Summer Trip might take us. Due to August trip dates, we had a few options, and chose to join the Praying Pelican Mission Youth Trips to Tulsa, Oklahoma. Eventually 5 youth and 2 adults agreed to attend this trip.

In May we celebrated the High School Seniors who were graduating. 10 Youth were a part of this celebration that included a Quilt Blessing during worship, card collection from the Kountze Memorial members for the graduates, a small reception for graduates and their families after the worship time. We are so grateful for the partnership with Kountze Women's Quilting Group that provided a quilt for each graduate.

The summer was filled with time to have pre-trip meetings for Tulsa. We made our plans and took to the road the Saturday, July 31<sup>st</sup>. What an adventure of being in a new place, sleeping on a church floor or pew, eating our meals with two other church groups, worshiping and serving through painting rooms, working with youth at Kid Club, and cleaning out a kitchen and storage area to prepare for it's use as a food pantry. When we returned to Kountze a week later, in the rainstorm of the century, we took time to prepare for a presentation on the trip. The following Sunday, we shared our experience on the trip and thanked the congregation and many individuals who sponsored us.

Before school started, we also held a mini-golf outing and a lock-in. We started the lock-in with service to the Kountze Food Pantry on a Friday Evening. We had two trips to deFreese Manor in the fall. One was a sing-a-long on a Saturday Morning. One was a fall clean-up of their garden where we returned to the church for a fire where we roasted hot dogs for our meal and made 'Smores.

The fall had us returning to the Youth Room between worship times for our Youth Forum. This time the invitation was for all  $7^{th} - 12^{th}$  graders to meet together each Sunday. We also started to make plans to attend the ELCA Youth Gathering in Minneapolis from July, 24 - 31. Once a month we participate in a bible study, check-in with each other, play games and try to find ways to serve in the world. We are especially grateful to the youth that are a part of Order of St. John and are willing to assist with worship each Sunday.

Mike Jensen served as Youth Council Representative for the year until Council Elections were held in September. Anne Dey is presently serving as Youth Council Representative.

#### **BOARD REPORTS**

#### **ENDOWMENT FUND**

The Endowment Fund is an integral part of the Church, extending Kountze's mission outreach. In doing so, it represents Kountze in our synod, our community, and globally. Its grants are intended to go beyond Kountze programs normally supported through regular offerings. Endowment also supports Kountze with the costs of Sunday morning media broadcasts, as well as with the capital expenditures encountered with being the stewards of such an honorable historic church building as we have been blessed to enjoy and care for.

Each year the amount of funds available for grants by the Endowment Fund is determined based on a formula in its Bylaws. For the year 2021, \$211,056 of funds was available for grants, and from these funds, the following grants were made.

- \$ 66,209 to Kountze for its Pantry's rent payment to KETV
  - 32,290 to Kountze for its Media Ministry
  - 24,420 to the Healing Gift Free Clinic for its rent payment to KETV
  - 20,000 to Kountze for Capital Improvements (windows and roof loan)
  - 20,000 to Together
  - 15,000 to Lutheran Family Services for Afghan refugee resettlement
  - 10,000 to NE Synod for ELCA Missionary Support
  - 5,000 to Lutheran Campus Ministries
  - 5,000 to Boys and Girls Clubs
  - 2,500 to Table Grace Ministries
- \$ 200,419 Total grants made in 2021

As of December 31, 2021, Endowment had a total of \$6,749,370 of funds in its investment and bank accounts. This is an increase of \$830,130 over December 31, 2020. This increase included two significant donations from the following:

- \$308,013 a bequest from the Estate of Thomas Jacobsen
- \$25,000 a gift from the Trust for Ronald Rasmussen

In addition to the funds in the investment and bank accounts, the Endowment Fund is also the sole owner of Kountze Endowment True Vision, LLC, a limited liability company commonly referred to as "KETV." (This KETV should not be confused with the TV station). KETV was organized for the sole purpose of owning and financing the property we commonly call Kountze Commons. In other words, KETV is a real estate management company. It rents the Kountze Commons facilities to various groups, including among others the Kountze Pantry, the Healing Gift Free Clinic, and the Methodist Community Health Clinic.

KETV is the primary entity liable for the debt on Kountze Commons. Its loan from MIF was guaranteed by Kountze. Rents received by KETV help with the monthly payments owed on the loan.

Endowment has been covering rents owed by the Kountze Pantry and the Healing Gift Free Clinic. Endowment provided the initial \$2.2 million of funds to KETV to purchase the Kountze Commons property. This is why Endowment is the owner of KETV.

In calculating the Endowment Fund value for purposes of determining the amount of funds available for annual grants, the value of KETV is not taken into consideration.

As it invests Endowment funds, the Board continues to utilize a broadly diversified portfolio which is implemented using low-cost exchange traded funds (ETFs). The portfolio is allocated to US stocks, non-US stocks, US bonds, non-US bonds, real estate via KETV, and cash. All investment strategies are passively managed. The weighted average annual investment management fee for the portfolio, excluding real estate, is approximately 0.05%.

For calendar year 2021, the investment portfolio of the Endowment returned about 8.4%, net of investment fees. With 40% of the funds in fixed income securities for safety purposes, this overall investment return for 2021 is considered a strong and acceptable performance for the fund.

The Endowment's investment portfolio asset allocation was 56.24% equity and 43.76% fixed income at year-end which is in-line with the target allocation of 60% equity and 40% fixed income. A large bequest coming into the bank account the last week of the year weighted more than usual to the fixed income allocation, and it will be reallocated to equity. This asset allocation is expected to generate the long-term returns necessary to support the Board's goals without taking undue risk.

#### DEFREESE MANOR

The board is currently negotiating the sale of deFreese Manor to another non-profit that has extensive experience with low-income HUD facilities. The board took the issue of selling the Manor to members of the church and held a vote twice during 2021 on whether to sell the building and property. Both votes of church members passed overwhelmingly with over 90% approval to move ahead with the sale as long as the mission remains of offering low-income housing to seniors. We expect to close on the sale in March or April of this year. Some highlights from 2021:

- We have fifty-one apartments with nine waiting to get in.
- We had six vacancies, 4 due to a higher level of care; two deaths not COVID-19 related.
- Our new Service Coordinator this year is Chelsea Oliver.
- The average age is seventy-six with 37% men and 63% women.
- Income limits have increased to \$30,750 for a single and \$35,150 for a couple.
- We have updated almost all apartment kitchens and baths nine left to complete.
- We hope to complete the project in 2022.

Our volunteers have been gardening when weather permits, providing callers for our bingo games but we are still in need of drivers for our bus (NO CDL license required). Thank you for your continued support of our mission working with seniors.
